How to Spot Fake News and Check Facts

Long before the era of social media and the internet George Bernard Shaw said ‘*Beware of false knowledge; it is more dangerous than ignorance*’.

By now all of us are familiar with the term fake news. It is not a new concept but it is certainly increasing in volume. Bogus stories are easy to distribute via social media platforms, messaging apps and emails. Remember the so-called announcements about when the President will address the nation about the lockdown stages and all the not so true infographics about the stage announcements? It seems that the Covid-19 pandemic is providing fertile ground for spreading fake news. Advancements in technology provide lots of opportunities to create fake news. An example is deepfake videos. A recent article in Popular Mechanics by Kristina Libby entitled [Deepfakes Are Amazing. They're Also Terrifying for Our Future](#) provides more information on this issue.

The International Federation of Library Associations and Institutions (IFLA) compiled a useful infographic with eight simple steps on ‘*How to spot fake news*’. The infographic is available at the end of the article but can also be downloaded at <https://www.ifla.org/publications/node/11174>. The infographic is based on the article by Eugen Kiely and Lori Robertson, entitled [How to Spot Fake News](#). Details on the eight steps to identify fake news are available in the article.

One of the eight steps mentioned in the Infographic is to Ask an Expert. This step refers to fact checkers. The website of International Fact-Checking Network, a unit of the Poynter Institute at <https://www.poynter.org/ifcn/>, provides valuable information on this subject. Africa Check, at <https://africacheck.org/>, is Africa's first independent fact-checking organisation. A checklist of fact-checking tips is available on the Africa Check website at <https://africacheck.org/how-to-fact-check/tips-and-advice/>. “[What's Crap on WhatsApp](#),” is a voice note podcast produced by Africa Check and podcast company Volume. The podcast is sent directly to subscribers on Whatsapp. It summarises the latest viral rumours submitted to Africa Check for evaluation.

We are unfortunately all exposed to misinformation and unsubstantiated stories. Critical evaluation and assessment of content are becoming essential. A healthy dose of scepticism is necessary to determine whether what you see and read can be trusted. Think before you believe what you see, read or hear, and certainly before you share.

HOW TO SPOT FAKE NEWS



CONSIDER THE SOURCE

Click away from the story to investigate the site, its mission and its contact info.



READ BEYOND

Headlines can be outrageous in an effort to get clicks. What's the whole story?



CHECK THE AUTHOR

Do a quick search on the author. Are they credible? Are they real?



SUPPORTING SOURCES?

Click on those links. Determine if the info given actually supports the story.



CHECK THE DATE

Reposting old news stories doesn't mean they're relevant to current events.



IS IT A JOKE?

If it is too outlandish, it might be satire. Research the site and author to be sure.



CHECK YOUR BIASES

Consider if your own beliefs could affect your judgement.



ASK THE EXPERTS

Ask a librarian, or consult a fact-checking site.

Labour Relations Act 66 of 1995, s 197 transfer – Transfer of employment contracts – Effective date of transfer – Effect of public or regulatory character of transferee.

Supreme Court of Appeal Decisions

Compcare Wellness Medical Scheme v Registrar of Medical Schemes and Others (267/2020) [2020] ZASCA 91 (17 August 2020)

Section 38(d) of the Constitution – organ of state acting in the public interest – reviewing its own decision – Promotion of Administrative Justice Act 3 of 2000 applies – Medical Schemes Act 131 of 1998 – Registrar of Council of Medical Schemes has no discretion to allow a medical scheme to change its name to a name that is likely to mislead the public – the Registrar has no power to impose allow a name-change subject to conditions.

Ngakantsi v S (1020/2020) [2020] ZASCA 94 (19 August 2020)

Appeal against refusal by high court of petition seeking leave to appeal against conviction and sentence by regional court – Leave to appeal to high court should have been granted – Merits of appeal to be determined by high court.

Passenger Rail Agency of South Africa v Sbahle Fire Services CC (230/2019) [2020] ZASCA 90 (4 August 2020)

Interpretation of agreement entered into between appellant and respondent in respect of which respondent rendered fire and safety consultancy services to appellant for prescribed fee – Whether appellant breached contract – Whether court *a quo* erred in dismissing appellant's claim in reconvention.

Proxy undertakings to vote at company meeting – Such meetings held and resolutions passed and implemented – Undertakings due to expire – Decision on appeal would not have practical effect or result – Appeal dismissed in terms of Superior Courts Act 10 of 2013, s 16(2)(a).

Defence Amendment Act 6 of 2020

"To amend the Defence Act, 2002, so as to include the Chief of Staff in the Military Command of the Defence Force; to clarify the process regarding the implementation by the Chief of the Defence Force of the delegation of powers and assignment of duties to members by the Secretary for Defence as head and accounting officer of the Department; to provide for the employment of the Defence Force outside the Republic; to simplify matters regarding identification cards issued to military police officials; to make a technical correction to the reference to the Armaments Corporation of South Africa Limited in section 18; to provide for the security vetting of contractors and service providers of the Department; to regulate the minutes of meetings of the Council of Defence; to clarify that a person does not need consent an employer in order to enrol as, or to remain, a member of the Reserve Force; to regulate anew the termination of service of members of the Regular Force; to amend the requirements for legal representation of members; to regulate the display of military decorations; medals and insignia; to regulate the use of military uniforms, distinctive marks and crests..."

Compensation for Occupational Injuries and Diseases Amendment Bill, 2020

Notice of intention to introduce in National Assembly and publication of explanatory summary.

The Bill seeks to amend the Compensation for Occupational Injuries and Diseases Act, 1993, so as to amend, substitute, insert, delete and repeal certain definitions and sections; to provide for matters pertaining to the Board and its members; to provide for the Commissioner to perform certain functions that were previously performed by the Director-General; to further provide for matters pertaining to the rehabilitation, re-integration and return to work of occupationally injured and diseased employees; to regulate the use of health care services; to provide for the Commissioner to review pension claims or awards; to provide for administrative penalties; to regulate compliance and enforcement and to provide for matters connected therewith.

Parliamentary Bills

Cannabis for Private Purposes Bill 19 of 2020

To—

- respect the right to privacy of an adult person to possess cannabis plant cultivation material; to cultivate a prescribed quantity of cannabis plants; to possess a prescribed quantity of cannabis; and to smoke and consume cannabis;
- regulate the possession of cannabis plant cultivation material; the cultivation of cannabis plants; the possession of cannabis; and the smoking and consumption of cannabis by an adult person;
- protect adults and children against the harms of cannabis;
- provide for the expungement of criminal records of persons convicted of possession or use of cannabis;
- delete and amend provisions of certain laws; and
- provide for matters connected therewith.

Children's Amendment Bill 18 of 2020

To amend the Children's Act, 2005, so as to amend and insert certain definitions; to provide for children's right to privacy and protection of information; to further provide for the rights of unmarried fathers; to extend the children's court jurisdiction; to further provide for funding of early childhood development programmes; to provide for the designation and functions for a Registrar of the National Child Protection Register; to further provide for the care of abandoned or orphaned children and additional matters that may be regulated; to further provide for rules relating to care and protection proceedings; to further provide for medical testing of children in need of care and protection or adoption; to provide for additional matters relating to children in alternative care; to further provide for matters relating to adoption and inter-country adoption; to further provide for the hearing of child abduction matters; to further provide for matters relating to surrogate motherhood; and to provide for matters connected therewith.

Criminal Law (Sexual Offences and Related Matters) Amendment Act Amendment Bill 16 of 2020

"To amend the Criminal Law (Sexual Offences and Related Matters) Amendment Act, 2007, so as to—

- extend the ambit of the offence of incest;
- introduce a new offence of sexual intimidation;
- further regulate the inclusion of particulars of persons in the National Register for Sex Offenders;
- make provision for certain particulars of persons who have been convicted of sexual offences to be made publicly available;
- extend the list of persons who are to be protected in terms of Chapter 6 of the Act;
- further regulate the removal of particulars of persons from the National Register for Sex Offenders;
- and further regulate the reporting duty of persons who are aware that sexual offences have been committed against children,

and to provide for matters connected therewith."

Domestic Violence Amendment Bill 20 of 2020

To amend the Domestic Violence Act, 1998, so as to—

- amend and insert certain definitions;

- further provide for the manner in which acts of domestic violence and matters related thereto, must be dealt with by certain functionaries, persons and Government departments;
- further regulate obtaining of protection orders in response to acts of domestic violence; •
- delete and amend provisions of certain laws; and
- provide for matters connected therewith.

Financial Sector Regulation Amendment Bill 15 of 2020

“To amend—

- the Insolvency Act, 1936, to clarify that the provisions of the Financial Sector Regulation Act, 2017, apply to the liquidation or sequestration of the estate of a designated institution; to exclude dispositions made in case of resolution from the application of the Insolvency Act; to clarify and refine the application of certain provisions of the Insolvency Act;
- the South African Reserve Bank Act, 1989, to provide for the performance of resolution functions by the Reserve Bank;
- the Banks Act, 1990, to exclude banks in resolution from the application of certain provisions; to provide for set-off against any amounts paid by the Corporation for Deposit Insurance; to repeal certain provisions;
- the Mutual Banks Act, 1993, to provide for the issuing of guidance notes and directives by the Prudential Authority; to provide for an offence in the case of non-compliance with a directive; to repeal certain provisions; to exclude a mutual bank in resolution from the application of certain provisions;
- the Competition Act, 1998, to exclude transactions in relation to resolution from the application of certain provisions; and to provide for consultation with the Competition Commission in relation to certain transactions;
- the Financial Institutions (Protection of Funds) Act, 2001, to exclude designated institutions in resolution from the application of certain provisions;
- the Co-operative Banks Act, 2007, so as to repeal certain provisions; and to exclude the application of certain provisions to co-operative banks as designated institutions;
- the Companies Act, 2008, to provide for the winding up of a company in resolution in certain circumstances; to exclude transactions, amalgamations or mergers or arrangements in relation to resolution from the application of certain provisions; to exclude an institution in resolution from the application of a Chapter;
- the Financial Markets Act, 2012, to exclude designated institutions from the application of certain provisions; and to exclude designated institutions in resolution from the application of certain provisions;
- the Financial Sector Regulation Act, 2017, to provide for the establishment of a framework for the resolution of designated institutions to ensure that the impact or potential impact of a failure of a designated institution on financial stability is managed appropriately; to designate the Reserve Bank as the resolution authority; to establish a deposit insurance scheme, including a Corporation for Deposit Insurance and a Deposit Insurance Fund; to provide for co-ordination, co-operation, collaboration and consultation between the Corporation for Deposit Insurance and other entities in relation to financial stability and the functions of those entities; to make provision for designated institutions in connection with resolution matters; to further provide for information required to assess a levy; to effect consequential and technical amendments to certain provisions; to accordingly amend the long title and the Arrangement of Sections; and
- the Insurance Act, 2017, to exclude certain insurers from the application of a Chapter; and to provide for matters connected therewith.”

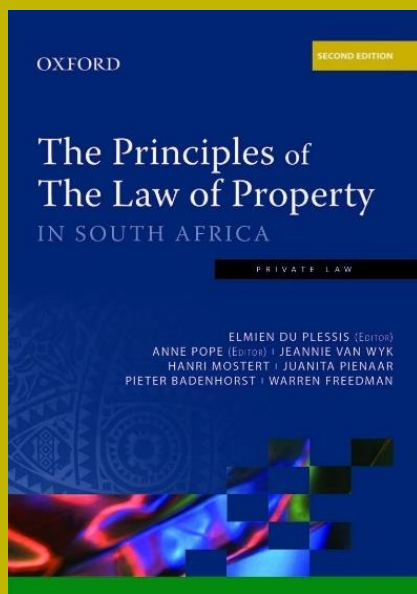

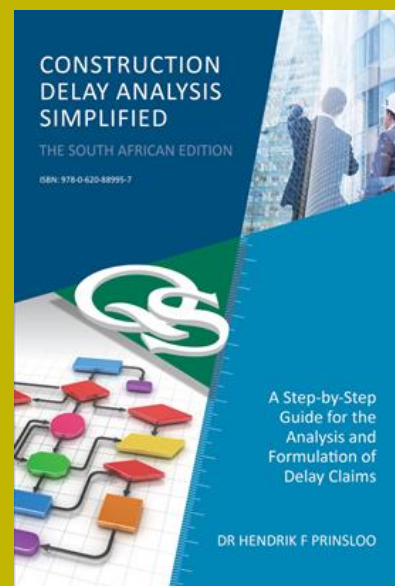

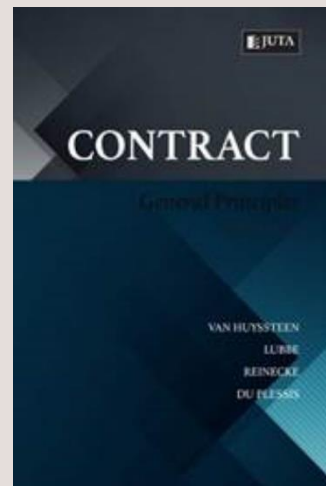
